

Lion Sports Bar "Win Unlimited Wings for a Year" Contest Terms and Conditions

1. Eligibility

- The Lion Sports Bar "Win Unlimited Wings for a Year" Contest ("Contest") is open to legal residents of the United States who are 21 years or older at the time of entry.

2. Contest Period

- The Contest begins on March 27, 2025, and ends on April 27, 2025 ("Contest Period"). Entries submitted outside this period will not be considered.

3. How to Enter

- To enter the Contest, participants must:
 1. Purchase an Order of Wings at Lion Sports Bar during the Contest Period.
 2. Receive an Entry Form upon purchase.
 3. Complete the Entry Form by guessing Bryce Harper's 2025 Full Season Batting Average and Number of Home Runs Hit, Including Postseason.
 4. Submit the completed form before the Contest Period ends
 5. Post a selfie with your Lion Sports Bar wings on Instagram Stories, Post or Reels and tag @lionsportsbar
 - Limit of one (1) entry per person. Multiple entries will lead to disqualification.

4. Entry Guidelines

- Entries must be fully completed with a valid legal name, Instagram handle, contact information, and the participant's prediction of Bryce Harper's 2025 batting average (to three decimal places) and total number of home runs.
 - Incomplete, incorrect, or fraudulent entries will be disqualified.

5. Determination of Winner

- The winner will be the participant or participants whose accurately predict Bryce Harper's 2025 season, including post season, batting average (to three decimal places, does not include preseason) and home run total regular and postseason combined.

- The official statistics provided by Major League Baseball (MLB) will be used to determine the correct results.
 - Authentication of required Instagram Story, Post or Reel is required for winner verification. Failure to provide verification will lead to disqualification.
 - The winner will be notified within 30 days of the end of the 2025 season via the contact information provided on the entry form.

6. Prize Details

- Prize: Unlimited wings at Lion Sports Bar for the duration of the 2026 Philadelphia Phillies regular season and postseason games.
 - Prize is dine-in only and can only be redeemed by the winner. Wings may not be shared, transferred, or taken to-go.
 - The winner is eligible to receive unlimited orders of wings per each Phillies game during the 2026 season. Prize must be redeemed between the first pitch of each game to the final out of the game. No substitutions or cash alternatives are permitted.

- The prize is valid only for the 2026 Philadelphia Phillies season, beginning with the first regular season game and ending with the last postseason game if applicable.
 - The winner must be present at Lion Sports Bar during Phillies games to claim the prize.
 - The prize is non-transferable and can only be redeemed by the winner. Sharing the wings or transferring the prize to another person will result in immediate disqualification and forfeiture of prize.
